



# DEAIS LAVA, RETARDER RELEASING-AGENT OF SURFACE SETTING FOR FACING AGGREGATE.



## Description

Gelatinous release agent in liquid shape, soluble in water, made of to delay the setting-time in surface layers of mortars or concrete, allowing an easy releasing and subsequent concrete cleaning leaving the aggregates exposed. It is applied without dilute or slightly diluted. It is soluble in water, anticorrosive, is free of chloride and is no toxic by inhalation.

## Aplication

To obtain a finish in the face side on aggregates, pavements, concrete prefabs, faced concrete, concretes in general where is required to obtain an effective support for further renders.

## Surface preparation

The surface must be clean and free of loose particles and suitably waterproofing before application of DEAIS LAVA.

## Modes of application

Shake well the content of the package before applying the product.

-Apply without dilute or slightly diluted by brush.

-DEAIS LAVA does not require that the product is dry for the placing of concrete into the moulds but it is only

properly to the moulds with a few depth in which a treatment by one of the sides is required and not in the sides beside the mould.

Waterproof properly the casings, protect them from the rain(avoid the draggin) before applying DEAIS LAVA.

Remove forms after 2 - 3 days when the mortar or concrete achieves enough resistance.

Just after the forms are removed the concrete surface must be cleaned with a strong jet (before 2 hours), cleaning carefully with a brush to may possible that the aggregate can be seen.

## Clean up

With plenty of water.

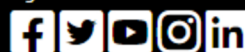
