Descripción

Special release agent for moulds made of wood and metal. It is used in moulds for work and prefabs. It doesn't produce spots on concretes both normal and white and allows to obtain surfaces with excellent quality and texture. It can be used on concretes placed by traditional methods, vibrated concretes, self-compacting, etc

Aplication

It is used in all types of moulds made of wood or metal both in work and prefab industry. It can be used on concretes placed by traditional methods as vibrated, self-compacting, etc.

Surface preparation

The surface of the moulds must be cleaned, free of dust, particles, wastes of mortars or concretes and dry.

Modes of application

Shake strongly the content of the package before using.

- Apply preferably as the product is provided.
- Soluble in gas oil and other hydrocarbons.
- The application must be done with brush, roller, spray can before placing the metallic armour.
- The concretes which going to be painted on or cladding with mortars must be washed with plenty of water

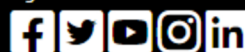
