




# EMPLAIS INTERIORES SUPER, POWDER PRODUCT FOR PLASTER OF STANDARD CURING



## Descripción

White powder product that mixed with water becomes in a plastic blend suitable for plastering cracks and scalings in walls and floors.

## Aplication

For removing unevennesses on surfaces to paint only for interiors. In plaster levelling. For removing cracks and fissures.

## Surface preparation

The surface must be clean and perfectly dry, free of grease, saltpeper being compact and without loose parts.

## Modes of application

Mix wit water until obtain the properly plastic blend to applied it easily.

Apply by a trowel without teeth or spatula in a thin layer.

Once the application is dry seal it with TEAIS, the only compatible.

With plenty of water.
