The soil must be absolutly clean from any pollutant, dust, grease, etc.

## Modes of application

Extend the product over soil by a mop and after rubbing down with a polishing machine provided of steel wood.

It is used undiluted on dirty soils. In a cleaner soils the product can be diluted from 1 to 2 parts with water. After this process CRISTAIS must be appllied.
