



# COAIS SUPER GEL, CHEMICAL SUPER CLEANER AGENT IN GEL CONSISTENCY.



## Description

Chemical super cleaner agent in gel consistency specially formulated for remove wastes of cement, rust, calcareous scaling and salts in several types of surfaces such as faced bricks, gresite, stoneware, stone, granite, formworks, work machinery, concrete-truck, pools, boats and several construction materials.

## Aplication

Very suitable for cleaning work wastes, cements, lime, rust and salts both in vertical and horizontal supports. It is used in slabs, ceramics, gres, natural stone, pools, facades, fountains, terraces, formworks, work machinery and metals.

## Surface preparation

It is required a test in order to verify the suitability to required use.

## Modes of application

The product can be applied pure or diluted, depending on the wastes to remove, position of the piece or zone to clean.

-In case of applying diluted the proportion must be until 1:4 in water, taken into account that the efficiency decreases when is diluted.

- Apply by brush on the area to treat and let it rest from 1 to 15 minutes taking into account that in order to know the proper time a previous test must be done.
- Finally clean the surface with plenty of water or with a product slightly alkaline to neutralize the acid wastes.

## Clean up

The used tools must be rinsed with plenty of water.

## Indications of danger:
