Aplication

Porcelain stoneware, ceramic and glazed stoneware, extruded stoneware, cement, wood, plastic sheets, linoleum, rubber and PVC, etc. TEAIS CLEANER is a cleaner suitable for maintenance.

Surface preparation

It is no necessary.

Modes of application

The product can be diluted on water in proportion 1:30 to 1:200.

- For the final cleaning on delicate surfaces the proportion must be 1:30.
- Spread it on the pavement by mop or rotative machine with soft disc. Pick up the waste and rinse with water.
- For using with clean and dry machines in high dilutions.

- For the usual maintenance in all types of surfaces, TEAIS CLEANER must be diluted in warm water in proportion of 1:200 and wash normally. For a deeper cleaning must be used higher dilutions.
