



**HIDROIMPER, Water repellent for facades, high capacity waterproofing for facades with porous surface.**



## Description

## Aplication

Water repellent very suitable for stone facades, exposed brick, concrete, single-layer mortars, lime mortars, plasters, etc. Does not change the aesthetic appearance and maintains the breathability of the façade

## Surface preparation

Support must be at least 28 days old. Totally clean, free of dust, paint, coatings. It cannot be used in permanent contact with water, on horizontal surfaces, or on surfaces below the water table. Cracks and fissures must be repaired before application, since the waterproofing agent for facades does not bridge cracks. Avoid contact with doors, windows, aluminum surfaces, glass, tiles, etc. The entire surface that is not going to be impregnated must be protected.

## Indications of danger:
