Resin finishing concrete printed PAVIMPRES pavements , which grants them very decorative satin finish. colorless

Aplication

It is applied as finishing resin for polished concrete pavements and stamped concrete pavements. It provides a remarkable aesthetic improvement, protects the surface and improves durability.

Surface preparation

The support on which the product is applied must be clean and dry. Free of dust and loose particles, firm and consistent.

Modes of application

- Mix the content of the package before using the product.
- Apply with a paint brush, roller or gun.
 - Apply RESIMPRES in a single coating directly onto the pavement to be protected, by thoroughly spreading the

product. If two coatings are required, the second layer is applied after allowing the first one to dry.
- Apply directly without diluting.
