Description

Liquid product that is applied superficiaclly on membranes of water-based elastomer waterproofing agents (Lastois Techumbres, Lastos Cubiertas, Lastois FHCV, Teais SK Film). It improves the resistance to water decreasing water spotting.

Aplication

LASTOIS RS is used for protecting and reinforcing to waterproofing based on water-based elastomers (Lastois Techumbres, Lastois Cubieras, Lastois FHCV, Teais SK Film).

Surface preparation

The elastomer where the product is applied must be dry, clean, free of dust and particles.

Modes of application

Stir well the content of the package.

- Apply one or two layers by roller on the membrane when it is well dry.
- Let dry well the first layer before applying the second one.
- The product is ready to use.
